### 2- PURPOSE OF PROCESSING OF YOUR PERSONAL DATA

## 3- METHOD AND LEGAL PROCESSING CONDITION OF COLLECTING YOUR PERSONAL DATA

Your personal data are collected and processed on the basis of the legal processing condition that data processing is compulsory for the legitimate interests of the data controller provided that the fundamental rights and freedoms of the data subject are not prejudiced as per article 5/2 (f) of the Law.

### 4- THE PARTIES TO WHOM YOUR PERSONAL DATA ARE TRANSFERRED AND PURPOSES OF TRANSFER

Within the scope of our processing purposes, your personal data may be transferred to digital agencies (in terms of social media accounts, websites) and PR communication agency, official, administrative and legal institutions, courts and execution offices and other relevant governmental agencies, organizations and institutions, counsels with whom a proxy relation has been established in case of probable legal disputes and financial advisers as well as information processing and database service providers whenever necessary, in compliance with article 8 of the Law.



#### 5- YOUR LEGAL RIGHTS AS THE DATA SUBJECT

Your rights of request within the scope of article 11 of the Law regulating the "rights of the data subject" consists of the following:

- a) To learn whether your personal data are processed or not,
- b) To request information if your personal data are processed,
- c) To learn the purpose of processing of your personal data and whether these are used for the intended purpose thereof,
- d) To get information about any third parties to whom your personal data are transferred in Turkey or abroad,
- e) To ask for the correction of your personal data in the event that they are processed incompletely or incorrectly,
- f) To request the deletion or destruction of your personal data within the frame of the conditions set forth in article 7 of the Law,
- g) To request the notification of the transactions performed as per clauses (e) and (f) to any third parties to whom the personal data are transferred,
- h) To object against an outcome to your disadvantage as a result of the analysis of your processed data exclusively through automatic systems,
- i) To ask for an indemnification if you incur a loss as a result of unlawful processing of your personal data.

Acting as the data controller, **AEP Anadolu Etap Penkon Gida ve Tarim Ürünleri Sanayi ve Ticaret Anonim Şirketi** will finalize your such requests within the shortest period of time possible or within thirty (30) days at the latest depending on the nature of the request on a free of charge basis.
